# **New Business & Other Information**

- Jeremy Jones announced his intention to step down as EBA President, effective September 30, 2020. The EBA thanks Jeremy for his years of service in various levels.
- Fall Ball ideas
  - Adrian will talk to school administration about a survey to be submitted prior to each night of participation. If the survey is not completed, a player may not participate that night.
  - A once and done medical waiver to be required.
  - There will be no registration in Stone Alley. Parents will have the option of paying \$5.00 per session, with a cap of \$75.00 for the entire season, or paying a one-time, non-refundable fee of \$75.00. We are planning on having three sessions per week for eight weeks, for a total of 24 sessions.
  - Tentative start and end dates are September 8, 2020 and October 31, 2020, respectively.
  - EBA will not be ordering hats and shirts for Fall Ball this season. We do have an overstock of Hardball
    Academy shirts and hats from previous years that can be purchased below normal cost at \$5.00 per shirt
    and/or hat.
  - We will need coaching staff for various levels of play.
- There will be no Alumni golf tournament this fall.

After a motion by Len Embiscuso and a 2<sup>nd</sup> by Mike Reading, the board voted unanimously to adjourn.

Next Board meeting is scheduled for 6:00 pm on Sunday, August 30<sup>th</sup> at Snyder Park. In case of inclement weather, the meeting will be held at the indoor facility.
